Cart Lease Agreement (for annual cart rentals)

1. At least one of the individuals named in the golfing membership agreement must be on the cart when in use. No one else can use the cart in the name of the renter.
2. Anyone riding with the renter who does not have a season cart lease must pay for half of the cart rental.
3. There are no restrictions on the number of holes a golfer with a cart lease can play.
4. Cart leases are honored during tournaments; however, they must be reserved a week in advance to ensure availability.
5. The renter is responsible for any injury to self, or others, as well as any property damage.
6. Cart drivers must be 16 or older or accompanied by a legal guardian.

Cart Storage Agreement

1. At least one of the individuals named in the golfing membership agreement must be on the cart when in use. No one else can use the cart in the name of the owner.
2. Anyone riding with the owner who does not have a season cart lease must pay a cart fee.
3. The cart owner is responsible for any injury to self, cart, or others, as well as any property damage.
4. Centennial Oaks is not responsible for damages or theft of cart or items with cart.
5. Cart drivers must be 16 or older or accompanied by a legal guardian.
6. Centennial Oaks reserves the right to move and/or use cart at times of need given that cart is not in use.
